ORDER

Subject:- Rajasthan Civil Services (Medical Attendance) Rules, 2013 - Maximum Chargeable rates of RGHS for treatment in Health Care Network Provider (HCNP).

In exercise of the power vested under Rule 20 of the Rajasthan Civil Services (Medical Attendance) Rules, 2013 and after considering the decision of Health Benefit Empowered Committee (HBEC) constituted under Rule 4 of these rules, the State Government has decided that:

- 1. For the particular treatment and length of stay shall be restricted for 5 days for medical management package.
- 2. Only following items shall be applicable for medical management package:
