## Notification

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules further to amend the Rajasthan Civil Services (Revised Pay) Rules, 2017, namely: -

**1. Short title and commencement.** - (1) These rules may be called the Rajasthan Civil Services (Revised Pay) (First Amendment) Rules, 2023.

(2) They shall come into force with effect from 01.04.2023.

**2. Amendment of Schedule-III.-** In the said rules in Schedule-III the existing entries appearing under heading " **Special Pay**", shall be substituted by the following, namely:-

## "Schedule-III (Rule No. 10) Special Pay

Special Pay as admissible to Government servants under Schedule-II of the Rajasthan Civil Services (Revised Pay) Rules, 2008 shall Continue to operate under the Rajasthan Civil Services (Revised Pay) Rules, 2017 till further orders except special pay of the category of posts mentioned as under:
