ORDER

Subject : - Office Allowance to the Patwaris of Revenue Department.

The Governor is pleased to order that the existing rate of 'Office Allowance' of Rs. 1000/- per month admissible to the Patwari's of Revenue Department, who are eligible for rent free 'Patwar Ghar' under proviso to sub-rule (2) of rule 12 of the Rajasthan Land Revenue (Land Records) Rules, 1957, under Finance Department order number F.6(4)FD/Rules/2007 dated 03.10.2013 is revised to Rs. 1200/- per month for hiring Patwar Ghar in addition to the amount of House Rent Allowance admissible to them in accordance with the provisions of House Rent Allowance Rules subject to the following conditions: -

- (i) that Patwar Ghar has not been provided by the Government and;
- (ii) one separate room is exclusively maintained by respective Patwari for the purpose of Official work and keeping records.

This order shall be applicable with effect from 01.07.2023.
