## NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Pension) (Amendment) Rules, 2024.
  - (2) They shall be deemed to have come into force with effect from 01-04-2024.
- 2. Amendment of rule 55.- In first provisio to sub-rule (1) of Rule 55 of the Rajasthan Civil Services (Pension) Rules, 1996, hereinafter referred to as the said rules, for the existing expressions "20.00 lac rupees", the expression "25.00 lac rupees" shall be substituted.
- 3. Amendment of rule 62.- In rule 62 of the said rules, the existing clause (a) of sub-rule (iii) shall be substituted by the following, namely:-
  - "(a) In the event of death of a Government Servant while in service, the family pension shall be payable to the family in following manner:-
    - (A) In the case where death is occurred before 1-4-2024, the family pension shall be payable to the family for a period of seven years following the date of death or till the date on which the deceased Government servant would have attained the age of 67 years had he survived, whichever period is shorter; and
    - (B) In the case where death is occurred on or after 1<sup>st</sup> April, 2024, the family pension shall be payable to the family for a period of ten years following the date of death of the Government servant."
