## **ORDER**

Sub: - Grant of Dearness Allowance to State Government employees drawing pay in the pre-revised pay scale/ grade pay as per 6<sup>th</sup> CPC.

The Governor is pleased to order that the existing rate of Dearness Allowance payable to the State Government employees, drawing pay in the Rajasthan Civil Services (Revised Pay) Rules, 2008, under Finance Department Order of even number dated 23-05-2025 shall be revised from 252% to 257% with effect from 01-07-2025.

- The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. sum of pay in running pay band and grade pay drawn and shall not include any other type(s) of pay like Special Pay or Personal Pay, etc.
- The payment on account of Dearness Allowance involving fraction of 50 paisa and above may be rounded off to the next higher rupee and the fraction of less than 50 paisa may be ignored.
- 4. The amount of increase in Dearness Allowance for the period from 01-07-2025 to 30-09-2025 shall be credited to the GPF Account as per provisions of Rajasthan Government Servants General Provident Fund Rules, 2021 as under:
  - (i) For the employees recruited before 1-1-2004 GPF Account.
  - (ii) For the employees who were recruited on or after 1-1-2004 GPF-2004 account.
  - (iii) For the employees of Autonomous Bodies / PSUs / Boards / Corporations etc. GPF-SAB account.
- 5. Cash payment shall be admissible from 01-10-2025 i.e. salary for the month of October, 2025 payable on 01-11-2025.
